Terms and Conditions

Definitions

"IWS" means the administrator, Integrated Warranty Systems Inc.

"Expiration of the Policy" means the date that the Policy Expires.

"Policy" means the Recreational Product Protection Policy administered by IWS that has a minimum term of forty-eight (48) months of additional coverage for ATV, Motorcycle, Personal Watercraft and Marine Policies and is identified with the Accompanying Policy Number listed in this Agreement.

General Provisions

1. The Policy meets the criteria to be eligible for this Coverage Commitment Agreement.
2. Only one (1) policyholder as named in this agreement is permitted. The Policyholder must be a real person and may not be directly or indirectly affiliated with the dealer, distributor, their agents or employees or other staff members or in any way associated with the sale and administration of the contract.
3. The benefit under this Agreement will be the reimbursement of the Retail Premium paid for the Policy less a \$50.00 administration fee, not including the premium paid for this coverage, to a maximum of fifteen hundred dollars (\$1,500.00).
4. This Agreement is not transferable between units or owners. It is valid for the original owner of the unit only.
5. This Agreement is non-cancelable after thirty (30) days from the purchase date except where the unit has been repossessed or written-off in an accident. Written proof of loss or repossession will be required and a pro-rated refund may apply.

Integrated Warranty Systems will refund the Premium paid for the Policy, as set out on the original purchase agreement, without interest, to the named Policyholder upon the expiration of the Policy provided:

1. The Policy has expired
2. The original Policyholder is the registered owner of the unit upon Expiration of the Policy
3. No claims have been made against the Qualifying Policy
4. The Policyholder submits a written request for a refund including a copy of the original purchase agreement, a copy of the Policy and proof of ownership to IWS within thirty (30) days of the Expiration of the Policy

Termination

This policy will automatically terminate without notice on the earliest of the following dates:

1. The date the unit is sold, traded-in or otherwise has a change in ownership.
2. The date that a claim is made against the contract.
3. The date that the unit is written-off in an accident or repossessed.
4. Thirty (30) days after the Expiration of the Policy.

This Agreement becomes valid once full payment, this document and the accompanying Recreational Product Protection contract are received by Integrated Warranty Systems Inc.
